An application has been made to the Registration Authority, the Lancashire County Council of County Hall, Preston, Lancashire PR1 8XJ ('the Registration Authority') by Mr A Greenwood ('the Applicant') under Schedule 3 paragraph 2 of the Commons Act 2006 and in accordance with The Commons Registration (England) Regulations 2008 ('the Regulations').

The application seeks to amend the register in consequence of the right of common being created through use of the right and attached to Higher Draught Gates Farm, Trawden. The right referred to is a right to graze 25 cattle and 100 sheep over part of CL183 known as Bouldsworth Hill including Deerstone Moor and Will Moor in the District of Pendle, Lancashire. For the right to be registered the Registration Authority will need to be satisfied that the supporting documents with the application has the effect of evidencing creation of the right and the land to which the right is attached is owned in part by the Applicant.

If the Registration Authority is satisfied that the evidence is sufficient it will accept the application will record the right.

The application and supporting documentation may be inspected between the hours of 9:00 am and 17:00 pm at the Office of the Chief Executive, Christ Church Precinct, Church Hall, Preston PR1 8XJ.

Any representations that are taken into account by the Authority in reaching a decision on the application cannot be treated as confidential and will be copied to the Applicants for comment in accordance with Regulation 26 and may be disclosed to other interested parties. If the application is referred to the Planning Inspectorate for determination in accordance with Regulation 27 of the Regulations any representations will be sent to the Planning Inspectorate.
